Some of our commissioners and staff were also pleased to attend the Service's community outreach event, Experience the Diaspora. We are always thrilled to see CPS members being proactive in building relationships with all segments of our community. Thank you to everyone who put this event together.

Commissioner Hanson was honoured to attend another recognition event mid month where a CPS member was recognized for her contributions to the Youth at Risk Development program with a King Charles the Third Coronation Medal. Thank you for letting us be a part of this special presentation!

Finally, our two new commissioners had the opportunity to go for ride alongs that gave them insight into the workload and experience of front line Patrol officers. These ride alongs are extremely helpful in building our understanding of policing, and I want to thank the members that accommodated them.

This coming month, our Commission is looking forward to the second Calgary Policing Summit on March 7. The event will bring together over 300 community and government leaders to discuss safety in public spaces. It is important to us that the community have input into the priorities and direction of the Service, and this event is one of the key ways we get that input.

To close my report, as always, I want to recognize some of the ways that CPS members have delivered on the priorities of Calgarians.

The Service's Online Stolen Property Team opened the month by shutting down a high-end bicycle chop-shop, where stolen bikes were being prepared for resale.

Investigators also successfully identified a suspect and laid charges in a series of storage locker break-ins. Property theft is a major concern for many Calgarians and these investigations highlight that there is a great deal of work occurring to address the problem.

Investigators also laid charges in several disturbing sexual assault files, including four against minors, one that occurred in an encampment, and a violent sexual assault by a stranger in 2019 that officers have been working to solve ever since.

Homicide investigators also were able to lay charges in a fatal Brentwood home invasion that occurred a year ago. These cases can be very complex and we appreciate all the hard work that goes into holding people accountable.

Finally, we would be remiss if we didn't mention all the front line patrol members who worked around the clock in extreme temperatures to make sure that help was there when people needed it.

Our Commission knows that there is immense pressure on frontline officers, and we will continue working with the province and Council to improve staffing levels. We are grateful for your hard work and cannot thank you enough.

These are just a handful of examples of what has been accomplished by the members of the Calgary Police Service this past month. On behalf of Calgarians, thank you for all your hard work to keep our community safe.
