This report is to be received by the Calgary Police Commission – Public Session for information and is the fourth of five reports scheduled in 2024-25 as we plan for the 2025 G7 Summit.

### Background / Analysis / Considerations

#### Background and Context

The Group of Seven (G7) brings together the world's leading economies (Canada, France, Germany, Italy, Japan, the United Kingdom, and the United States, as well as the European Union) to address global challenges and shape international policies. In 2025, Canada will host the G7 Leaders' Summit in Kananaskis, Alberta, uniting global leaders for three days of critical discussions on issues like climate change, gender equality, and economic stability.

The RCMP will lead the Summit's security efforts and have asked the Calgary Police Service (CPS) for assistance. In addition to assisting the RCMP, the CPS will carry out its duties as the police of jurisdiction (POJ) for Calgary-based events, ensuring local safety and supporting the success of this prestigious international event.

It is the responsibility of the CPS to report on the categories outlined in the "CPC Governance Manual" under the "Policies Governing the Calgary Police Service" for major events, under the following sections.

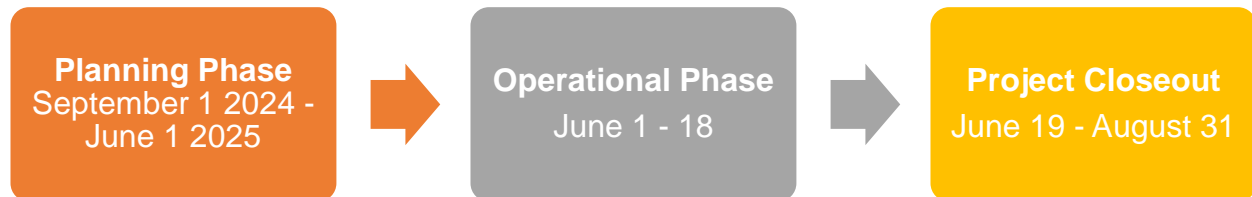
### 9.3 a): The nature of the event

- Dates: June 15-17, 2025
- Location: Kananaskis, Alberta, and various sites in Calgary

- Project timeline: September 2024 – August 2025
  - The CPS is at the end of the planning phase of the project. The Operational Phase begins on June 1, 2025.



- Staff requirements:
  - The CPS has been engaged in planning and consultation with the RCMP to determine the resource requirements to successfully manage this event.
    - CPS security partners (this will be any law enforcement agencies with which CPS establishes MOUs) have been finalized, which include:
      - Edmonton Police Service (EPS)
      - Vancouver Police Department (VPD)
      - Winnipeg Police Service (WPS)

### 9.3 b): Priorities and objectives

The CPS will be supporting the RCMP in advancing their Mission Statement:

- Ensure the protection of the general public and heads of state participating in the 2025 G7 Summit in Kananaskis, Alberta.

The CPS supports the RCMP's mission statement while prioritizing the safety and security of Calgarians, minimizing disruptions to daily life throughout the G7 Summit.

### 9.3 c) Operational plans

- The operational plans have been finalized.
- All plans underwent continual refinement, focusing on addressing risks and validating planning assumptions.
- The CPS and RCMP have collaborated effectively, aligning plans, and successfully testing and mobilizing CPS and security partner resources.
- Staffing requirements for the G7 Summit have been identified and filled. This ensures that effective and efficient service delivery to Calgarians will be maintained.

### **9.3 d-ii) Risk management, challenges and gaps.**

- CPS has been actively identifying and creating plans to mitigate risks for the 2025 G7 Summit.
- Our risk management is supported and included in the RCMP's risk management plan through the Integrated Risk Management Team (IRMT). The IRMT addresses risk mitigation via a collaborative, formalized process that involves identifying, assessing, mitigating, monitoring, and addressing risks using a Risk Register template.

### **9.4 d-ii): Is the Service taking operational direction from another entity.**

- The RCMP is the lead policing agency for the G7 Summit and has requested support from the CPS. While the CPS is working closely and collaboratively with the RCMP and Public Safety Canada as the POJ, we maintain independence in planning and operational decision-making for regular police operations within Calgary.
- The CPS has established a command structure that mirrors the RCMP's to ensure that the interests of The City of Calgary and the Calgary Police Service are represented.
- Legislation and policing standards involved will include adherence to national, provincial, municipal laws, and the Police Act as well as compliance with established policing best practices and standards.
- Most importantly, the CPS is well represented in the Integrated Safety and Security Group (ISSG), working collaboratively with all security partners. The ISSG model provides clearly defined roles fostering an environment of collaboration. This ensures that the CPS is represented as an equal partner while fulfilling responsibilities as the POJ.

### **9.4 d-iii): Funding and resource agreements**

- The CPS has received validation and approval for the required budget to support G7 summit from Public Safety Canada, along with endorsement from the RCMP.
- Costs incurred by the CPS for the event will be covered by federal funds through the Major International Event Security Cost Framework (MIESCF).
- These costs will be managed via an ongoing peer review process and are subject to audit. The CPS must provide evidence that the costs are directly related to G7 policing and security measures and exceed normal jurisdictional responsibilities.
- The costs will only be publicly available after the end of the G7 Summit and will be provided by Public Safety Canada, not the CPS. This event is not anticipated to negatively impact the CPS budget.

### **9.4 d-iv): Command and control structure**

- The RCMP Commissioner retains overall command and control over the G7 Summit security and operations, delegating authority through a structured chain to ensure effective coordination among multiple security partners. This will be managed using the Incident Command System (ICS), to clarify roles, responsibilities, and reporting lines.
- As the POJ, the CPS retains command over all planning and operational matters within The City of Calgary. The CPS will also manage planning and operations using ICS.

### **9.4 d-v): Complaints of misconduct**

- Complaint against any CPS sworn members during the G7 Summit will follow the regular Professional Standards Section (PSS) process.

- Complaints placed against officer from mutual aid agencies are most often referred back to the home jurisdictions who will be responsible for conducting the disciplinary investigation and complaint disposition.

#### 9.4 d-vii): Facility and equipment requirements

- CPS has identified, secured, and finalized equipment and resources required to support the G7 Summit.

## Highlights and Next Steps

### Milestones achieved:

- The operational plans have been finalized.
- Staffing requirements for the G7 Summit have been identified and filled.
- All plans ensure that effective and efficient service delivery, safety, and security to Calgarians is maintained.
- The CPS has received budget approval from Public Safety Canada and endorsement from the RCMP to support the G7 Summit. Event costs will be covered by federal funds through the Major International Event Security Cost Framework (MIESCF).

- Operational Phase – June 1 to 18, 2025

# NO DRONE FLYING ZONE



This is your **reminder that drones are strictly prohibited in and around the following areas** due to aviation regulations and temporary Summit-related restrictions:

- **Banff National Park** – Drones are never permitted in Banff. This is a year-round federal regulation to protect wildlife, visitor safety, and airspace integrity.
- **Kananaskis Country** – In Alberta's provincial parks, the use of any drone, Unmanned Aerial Vehicle (UAV) or Remotely Piloted Aircraft System (RPAS), regardless of size, is prohibited for recreational use.
- **YYC Calgary Airport** – No drone flights allowed:
  - Within 3.5 nautical miles from the centre of the airport
  - Within 1 nautical mile from any heliport

**Fines and penalties:** Under Canadian Aviation Regulations, unauthorized drone use can result in jail time or fines **up to \$15,000** for putting aircraft and people at risk.

Drones are not toys. They can interfere with aircraft, emergency operations, and security measures. **Leave your drone at home.**

# CPS FUNDING & RESOURCING REQUIREMENTS



- Public Safety Canada has **approved the proposed CPS budget**, with endorsement from the RCMP.
- Covered by federal funds through the Major International Event Security Cost Framework (MIESCF).
- The costs will **only be publicly available after the end of the G7 Summit** and will be provided by Public Safety Canada, not the CPS.
- This event is **not anticipated to negatively impact the CPS budget**.
- Through planning, **the CPS has adequate staffing resources** to support G7 operations and maintain policing duties to Calgarians.
- The CPS is currently in the process of identifying, securing and finalizing equipment and facility resources required to support G7.
- We are working on **a contribution agreement with CPS legal and the City of Calgary's legal and Capital Planning and Business Services teams**.
